- 1. The Kingdom of Cambodia has received a Credit from the World Bank toward the cost of Higher Education Improvement Project, and it intends to apply part of the proceeds of this Credit to payments under the Contract for MoEYS-HEIP-NS-W-047.
- 2. **The construction period is 300 Calendar Days.** Construction is scheduled to begin on December 2021 and completed by end of October 2022.

 - (a) Have completed at least two contracts of similar works in the preceding 3 years of a value not less than 75% of the quoted price.
 - (b) Have completed contracts with a total cumulative construction turnover in the preceding two years equal to at least 1.5 times of the value of quoted price.
 - (c) The proposed works manager must have at least 3 years of experience in the supervision of works of an equivalent nature and size and no less than one year as a manager.
 - (d) Submit documentary evidence to demonstrate the bidder's qualifications.
- 6. Quotations must be delivered to the address given below on or before **28 October 2021 at 3:00 p.m.** (Cambodia Standard Time). Late Quotations will be rejected. Quotations will be opened in public immediately thereafter at the same address in the presence of the Bidders' representatives. Bidders shall not have the option of submitting their Quotations electronically.
- 7. The Employer shall award the Contract to the Bidder whose offer has been determined to be the lowest evaluated quotation and is substantially responsive to the Bidding Documents, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.
- 8. All quotations must be accompanied by a performance securing declaration as described in the Bidding Documents. Any quotation not accompanied by one will be rejected as non-responsive.
